Sir,

Please refer to your RTI application dated 08.05.2017 received in this division on 17.05.2017 wherein you have sought information regarding enrolment related policy and document required from this office.

2. The Para wise reply are given as under:-

Para 1. This point does not pertain to this CPIO. Hence, it was transferred vide letter No. 4(4)/57/124/RTI/2016-E&U-II dated 18th May 2017 to other CPIO alongwith a copy to the applicant (copy enclosed).

Para 2. No. As per Para 11 (2) of Aadhaar (E&U) Regulations, 2016, UIDAI has made mandatory scanning of documents for enrolment of residents w.e.f. 1st Jul, 2016.

Para 3. Yes. Information cannot be provided under section 8(1) (a), (e) and (g) of the RTI Act 2005.

Para 4. The copy of the requested procedure, i.e. list of "Verification of enrolment Information" is enclosed.

Para 5. UIDAI investigate the reported cases of Aadhaar Omission (cancellation) or deactivation (suspension) of the residents as per Para 29 of the Aadhaar E&U Regulation, 2016 :-

Inquiry into cases requiring omission or deactivation:-


(1) Any case reported or identified as a possible case requiring omission or deactivation may require field inquiry which may include hearing the persons whose Aadhaar number is sought to be omitted or deactivated.

- (2) An agency nominated by the Authority shall examine/inquire and submit report to the Authority as per the procedures as may be specified by the Authority for this purpose.
- (3) The Authority may initiate necessary action upon receiving the report and the decision to omit or deactivate an Aadhaar number shall lie with the Authority.

3. If you are not satisfied with the reply, you may appeal to the First Appellate Authority, UIDAI within 30 days from the receipt of this letter.
