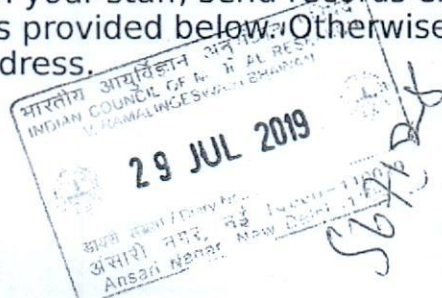
- ✓ 1) Please provide the name of Director for each institute during period 1 March 2015 to 31 June 2019.


