



3. I would like to know if Nestlé has conducted any studies or assessments on the health implications of adding sugar to infant milk and baby cereals, particularly in the context of the Indian population.
4. Please share any communication or correspondence between Nestlé and regulatory authorities in India regarding the use of sugar in infant milk and baby cereal products.
5. Additionally, I request information on any consumer complaints or feedback received by Nestlé related to the sweetness levels or sugar content in their infant milk and baby cereal products.
6. Whether the Department are conducted inquiry against the officer who approved Nestle and other children products/babies products or not .please provide full detail


