Please provide clear copies of any gazettes, notifications, circulars or any other public communications, as well as checklists, internal reports, budget documents, meeting notes, office memos or emails that provide information on this matter. See Section 2(i) and 2(j) of the RTI Act (2005).

In conforming to Section 6(3), if this information is not within your control please transfer the request to the appropriate PIO and inform me of the transfer.


