Subject: Provide the details on major fire broke out in late night hours

Dear Sir/Madam:

Pursuant to the Right to Information Act (2005), I hereby request the following information:

On 20 August 2020, a major fire broke out in late night hours in an underground hydroelectric power plant in Srisaillam in the state of Telangana. The fire blaze killed 9 people, including 5 engineers.

1. Provide the details of equipment damaged in the fire.
2. Provide the value of the equipment damaged.
3. Provide the details equipment which is damaged in the incident is repaired. If repaired, was it commissioned. If commissioned, when was it commissioned
4. From the time of the accident to the date of commissioning of the damaged equipment, Provide the number of units of potential power generating capacity in MW Hrs was lost.
5. Provide the power generating capacity in MW before the fire accident
6. Provide the details of the power generating capacity now.

Please provide clear copies of or verified links to any gazettes, notifications, circulars or any other public communications, as well as reports, budget documents, expense statements, invoices, meeting notes, checklists, office memos or emails that provide information on this matter. See Section 2(i) and 2(j) of the RTI Act (2005).


