
As per the instructions of the Divisional Forest Officer, Wildlife management, Atmakur in the reference cited, the required information requested by Sri Kareem Ansari R/o Hyderabad under RTI Act, 2005 is furnished below.

1. List of Tigers Present in the forest of Andhra Pradesh from 2012 to 2022 along with the area of concerned FRO and DFO.
 - a. The list of Tigers present in the forest of Andhra Pradesh information cannot be disclosed as per section 8 (g) and (h) of RTI Act, 2005. The Area of Bairluty Range jurisdiction is 13232.40Ha.
2. Number of Tigers Deaths occurred from 2012 to 2022 along with postmortem report and cases filed year wise.
 - a. This is submitted that, In Bairluty range 01 No Tiger was dead .The postmortem report and other details cannot be disclosed as per section 8 (g) and (h) of RTI Act, 2005.
3. Conservation steps taken to avoid future deaths of Tiger by poaching or Road accident from 2012 along with Budget allocated and spent (Year Wise).
 - a. In Bairluty range conduct Anti snare Drive, along RF border, agriculture fields and previous poaching areas by Forest staff. Wildlife Protection and Rescue Party was formed by Divisional Forest Officer, WLM, Atmakur, to avoid road accidents in Reserve Forest Speed limit Sign boards and speed breakers were placed at animal crossing zone.
