Please refer to this Department registration No. DOA&C/R/2018/00897 dated 25.07.2018. As far as Seed Division-VI is concerned, to upgrade the quality of farmers saved seeds, financial assistance@ 50% for providing certified / foundation seeds of *cereal crops* and assistance@ 60% for *oilseeds, pulses, fodder and green manure crops* to the farmers is now available in the component *Seed Village Programme*. Similarly to enhance the certified seed production of Pulses, Oilseeds, Fodder & Green Manure crops in the country, financial assistance @75% for distribution of foundation seeds of these crops is available to the farmers under component *Certified Seed Production of Pulses, Oilseeds, Fodder and Green Manure crops through Seed Village of Sub Mission on Seeds & Planting Material (SMSP)*. The SMSP was initiated during the year 2014-15. The above schemes are demand driven and implemented by *concerned State/implementing agencies* for the welfare of all the farmers in the country.

For further information regarding other various welfare schemes related to Agriculture, farmers suicide cases etc., in the State of Telangana, your application is being forwarded under Rule 6 (3) of the RTI Act, 2005 as the subject matter relates to the Commissioner /Director of Agriculture, Govt. of Telangana, Hyderabad for information and necessary action.
