- g) Total number of Cows present in each shelter. Please provide number of Cows dead in each shelter with their death reasons.
- h) How many workers are working in each Gaushalas? What are the wages given to them?



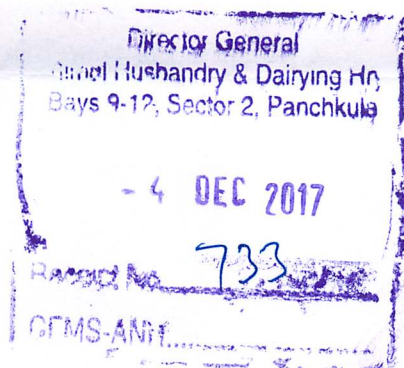

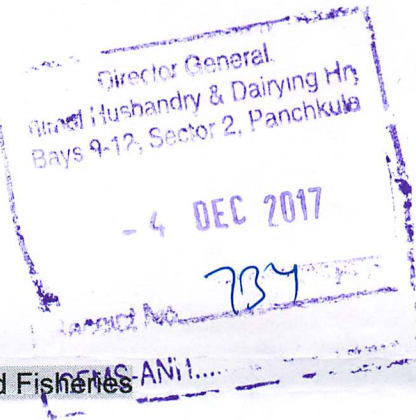
