Bank notes with writings on them continue to be legal tender. They can be deposited in bank account or exchanged at any of the bank branches. However, bank notes with religious or political messages are not eligible for exchange as per RBI (Note refund) Rules 2009.  RBI has issued clarifications on the validity of bank notes with writing on them through its press releases dated December 31, 2013 and December 14, 2015 which are available on our website www.rbi.org.in
