This has reference to your RTI application no. Nil dated 10.11.2017 received at our office on 13.11. 2017.As desired, we furnish below the reply to the information sought as available, in seriatim.

Q (A):

On 6th January 2013, an explosion set off a major fire at a diesel storage tank of Indian Oil Corporation's (IOC) Hazira terminal in Surat. A committee was set up by the Ministry of Petroleum and Natural Gas to probe the incident.

Please provide certified copy of the reports submitted by the Committee to the Ministry of Petroleum and Natural Gas (MoPNG) and Oil Industry Safety Directorate (OISD).

Reply:

The information sought by you includes the information of commercial confidence, the disclosure of which would harm the competitive position of the third parties and no larger public interest warrants disclosure of such information. Exemption from disclosure of such information is also available u/s 8(1)(d) of RTI act, 2005.

This also includes the information, the disclosure of which would endanger the life or physical safety of any person or identify the source of information or assistance given in confidence for law enforcement or security purposes u/s 8(1)(g) of the RTI act, 2005.

Please provide clear copies of or verified links to any gazettes, notifications, circulars or any other public communications, as well as reports, budget documents, expense statements, invoices, meeting notes, checklists, office memos or emails that provide information on this matter. See Section 2 (i) and 2 (j) of the RTI Act (2005).
