

**12.0 OVERSTAYAL OF LEAVE**

An employee who remains unauthorisedly absent and does not report for duty within 15 days from the date of expiry of leave granted to him / her shall lose lien on his post and shall be deemed to have voluntarily left the service of the Corporation without notice. However, if the employee is subsequently able to account for his unauthorized absence to the satisfaction of the Management the latter may regularize the period of absence in the manner deemed fit and covered by the rules, and allow the employee to continue in service.
