(Copy Enclosed). As such the CID, Crime Branch being a notified organisation u/s 24 (4) of RTI Act is not subjected to the purview of the RTI Act. Hence the information sought for is denied.

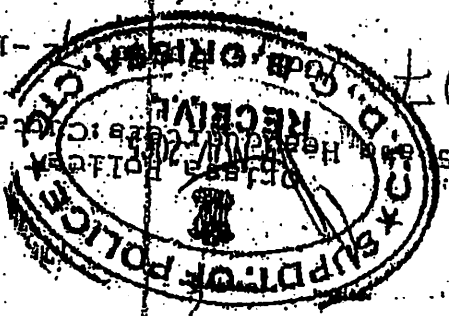
