NO.SW/JUV-9/26/2013: It is hereby Notified to all concerned Departments to take necessary measures to ensure implementation of the following provisions under the Juvenile Justice (Care and Protection of Children) Act, 2015 which prohibits misuse of children from activities speci ied as per the provisions of law under:-

- (a) Section 77. Whoever gives, or causes to be given, to any child any intexicuting liquor or any narcotic drug or tobacco products or psychotropic substance, except on the order of a duty qualified medical practitioner, shall be punishable with vigorous imprisonment for a term which may extend to seven years and shall also be liable to a fine which may extend up to one lakh rupees.
- (b) Section 78. Whoever uses a child, for vending, peddling, carrying, supplying or smuggling any intoxicating liquor, narcotic drug or psychotropic substance, shall be liable for rigorous imprisonment for a term which may extend to seven years and s all also be liable to a fine up to one lakh rupees.
