Sl. No	Information Sought	Reply
1	Conduct periodic inspections and audits of medical device manufacturers and distributors to ensure compliance with the Legal Metrology (Packaged Commodities) Rules, 2011.	Regular inspections are conducted on the devices covered under the Legal Metrology general rules 2011.
2	Impose penalties on those found non-compliant with the rules and create a different effect for others.	Penal action is being initiated as deemed fit under law.
3	Create awareness among the public and medical device manufacturers about the importance of adhering to these rules and the consequences of non-compliance.	Consumer awareness camps are conducted time to time.
4	Encourage the use of standardized formats for displaying the required information on medical devices.	Not covered under the Legal Metrology Act, 2009.
