Sir,

Please refer to your RTI application having Registration No. DOA&C/R/2018/00891 dated 25.7.2018 received through RTI cell of this Department. It is informed that in respect of point no. 2 & 3, the Credit-II-Division implements Central Sector Schemes Pradhan Mantri Fasal Bima Yojana (PMFBY), Restructured Weather Based Crop Insurance Scheme (RWBCIS), Coconut Palm Insurance Scheme (CPII) Pilot Unified Package Insurance Scheme (UPII) for farmer's welfare. No direct payment is made to State or farmers under Crop Insurance Scheme by Credit-II-Division. Funds are provided against the committed liability of Govt., contribution in premium subsidy to Agriculture Insurance Company (AIC) of India Ltd., which is the fund-routing agency for onward release to the empanelled Insurance Companies. Insurance Companies assess the admissible claims as per provision/criteria of the schemes and settle claims of the farmers accordingly. These schemes are demand driven. The State wise information under PMFBY is enclosed herewith **Annexure-1**.
